Holistic Needs Assessment (HNA) & Personalised Care Support Plans (PCSP)

We know that people are more than their cancer diagnosis. A HNA is an important part of the care that every patient should be offered at the point of diagnosis and throughout their treatment. We have worked with a number of patient and carer representatives to create a leaflet to promote HNA's to make sure every patient knows what they are entitled to and how a HNA could help them to find the support they need.
