- Interest in, and passion to improve, diagnostics and pharmacy services across Greater Manchester
- An interest in working collaboratively to improve the outcomes and experiences of patients in Greater Manchester.
- Ability to communicate with and challenge professionals constructively and respectfully, where necessary.
- Ability to listen to and respect different perspectives, display empathy, and be open to other points of view.
- Ability to self-assess and be aware of personal emotive topics, and to speak objectively when doing so.
- An awareness of and commitment to equality and diversity.

What we need you to do

- Attend and actively participate in GM Diagnostics and Pharmacy Partnership Group meetings, or let us know if you will be unable to attend
- Read the meeting papers, which will usually be circulated 1-week before the meeting
- Engage with other Patient and Carer Representatives sitting on a range of other Programme and Pathway Boards and within the Cancer Voices Community, relaying information in an understandable format
- Champion the diverse views of patients
- Provide some challenge as a critical friend into the meetings, advising the group on the patient/carers perspective
